# Commercial Real Estate Finance and Investment

## 2 – 3 November 2017, Mannheim, Germany

The Leibniz Network on Real Estate Markets and Capital Markets (ReCapNet) focuses on the interactions between real estate markets and capital markets. The ninth conference of the network will take place at ZEW in Mannheim on November 2 – 3, 2017.

The main theme of the conference will be “Commercial Real Estate Finance and Investment”.

A non-exhaustive list of potential topics includes:

- ▶ Commercial real estate finance and securitization
- ▶ Risk, return and pricing of commercial real estate asset classes
- ▶ International diversification benefits in commercial real estate
- ▶ Green building and sustainability
- ▶ Regulation and taxation of commercial real estate vehicles
- ▶ REITs, REOCs, Real Estate Private Equity and Real Estate Debt Funds
- ▶ Spill-overs between commercial and non-commercial real estate

We solicit submissions on these and other aspects of the nexus between commercial real estate markets and capital markets. Papers will be selected based on a competitive double-blind peer-review process. Contributions are welcome from both established and junior researchers.
